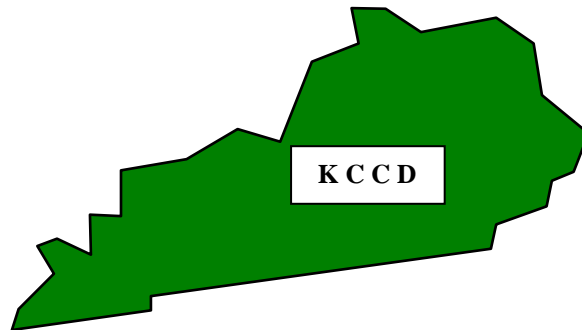

**The Association**
